0220. Approval of Agenda

0221. **Approval of Minutes**

Motion by C. Conroy, seconded by Carlow to approve minutes of the March 17, 2014 mid-month meeting. Motion carried unanimously.

0222. <u>Administrative Reports</u>

Board members held discussion with administrators regarding board reports recently submitted from each department director and school principal.

0223. Policy Introduction

Superintendent Ertz informed the board that the committee was unable to meet, as scheduled, to review sections D, I, and J, therefore, they will be presented to the board for their review at the next meeting. (Attachment B)

0224. <u>Job Description Update</u>

Superintendent Ertz provided the board with proposed revisions to employee job descriptions for their review, in an effort to make them more consistent and accurate. Once the board has provided input, the revised and updated job descriptions will be provided to employees with their new contracts issued for the 2014-15 school year.

0225. Title VII Summer Activities

Administration provided information in regard to planning for a summer art and reading camp, culture camp, and science and math camp, each being one week in length. In addition, administration is proposing adding a one-week life skills camp at each school site for 5th-7th graders. These camps and activities will be funded by remaining Title VII funds.
